Survey support services for Utility Locates along W. Irlo Bronson
Memorial Highway for the AMYL Center

Dear Imam:

Pursuant to a request from Mr. Ray Stangle, PE with Jordan & Associates for surveying services on the above referenced site, the following is an outline of the scope of services.

TASK I: Perform a route survey along the South side of Highway 192 within the limits outline on the attached Exhibit "A". Locate all surface features therein. Coordinate with Blood Hound Utility Locates (BHUL) to designate and mark the underground utilities within the route shown on attached Exhibit "A". Locate utilities as marked by BHUL and update existing Boundary & Topographic survey dated 1-16-17. Coordinate with Ray Stangle and if possible soft dig the connection points for the water line. Return to the site and locate the soft dig findings and update the survey.

Final deliverable will be 4 signed / sealed boundary & topographic surveys prepared in AutoCAD at a scale of 1"=40'.

Summary of Fees:
